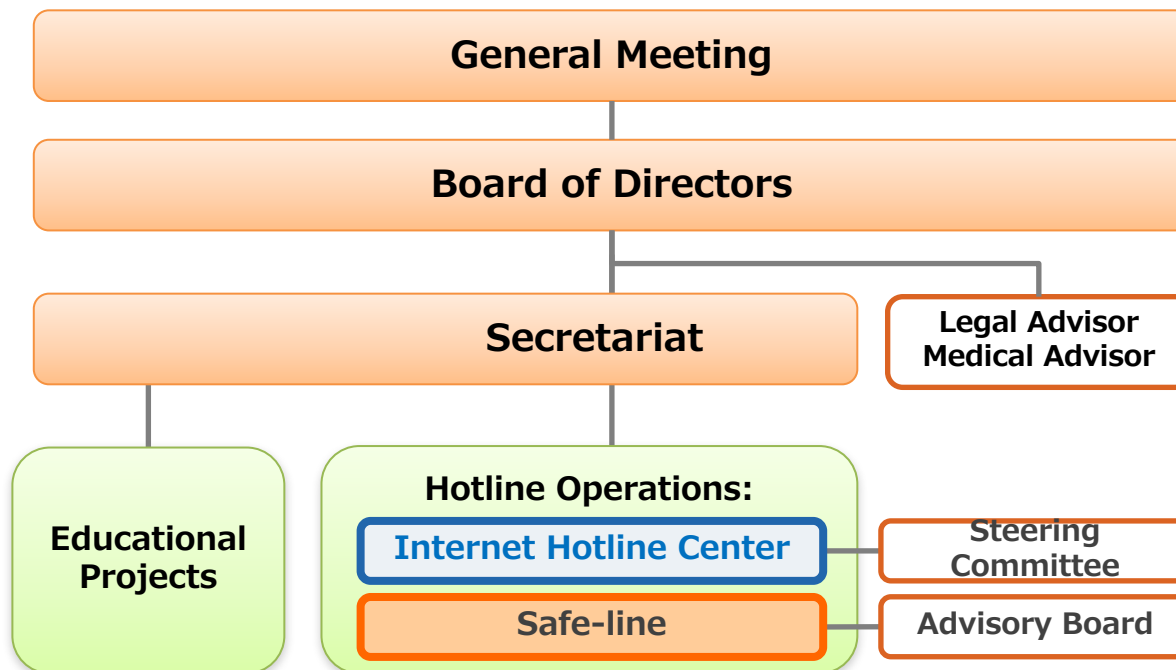

Notifies **domestic providers** of removal of illegal content (CSAM, drugs, obscene etc.)



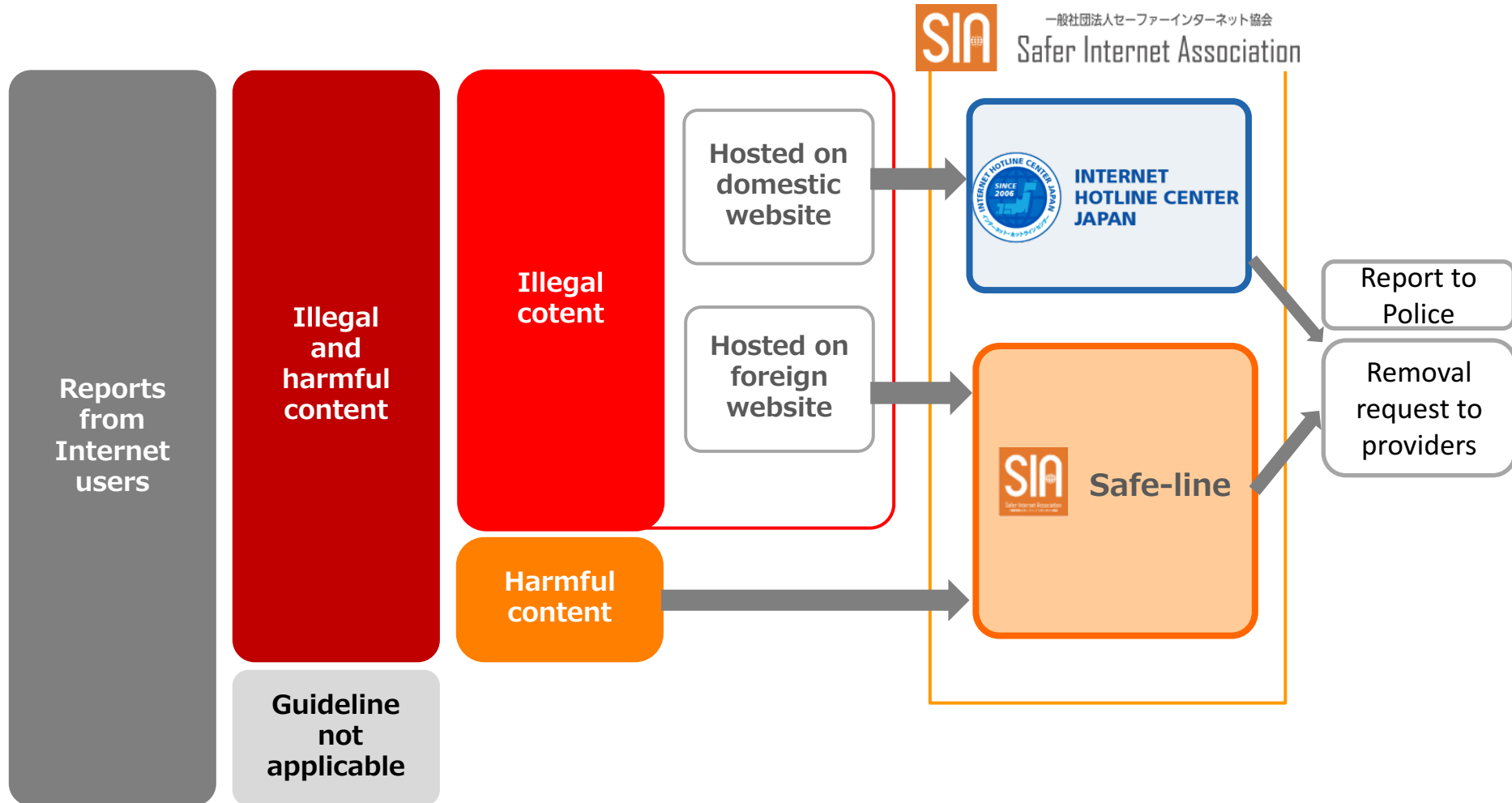
Safe-line

Funded by membership fee of SIA

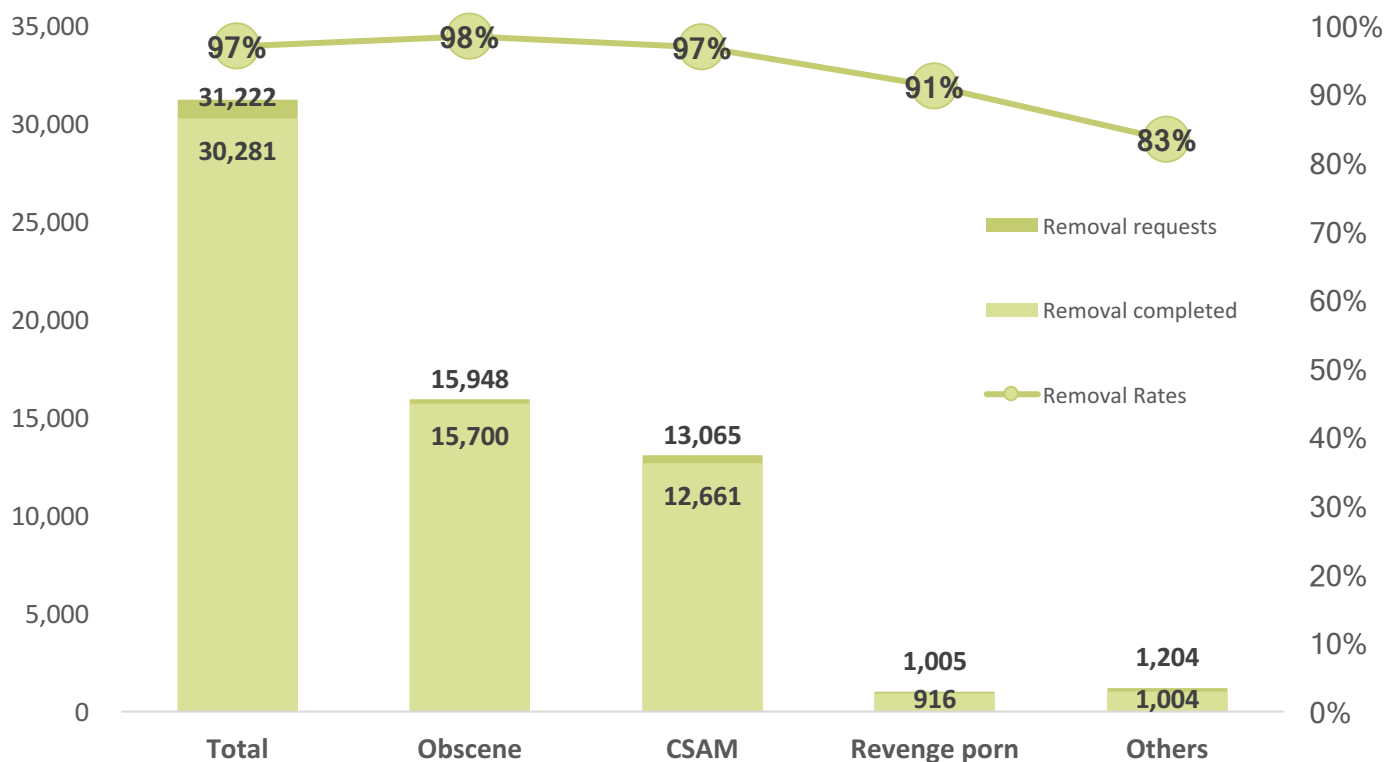
Started operation in November 2013.
Notifies mainly **overseas providers** of removal of illegal content and harmful content
(Revenge porn, cyber bullying, corpse etc.)

Removal Rate by Content Type

- Removal rates for “Obscene materials” was 98%, “Child Sexual Abuse Materials(CSAM)” was 97%, both achieving a high level of removal rate. In addition, removal rate of “Revenge porn” which is handled by Safe-line, is also high at 91%.

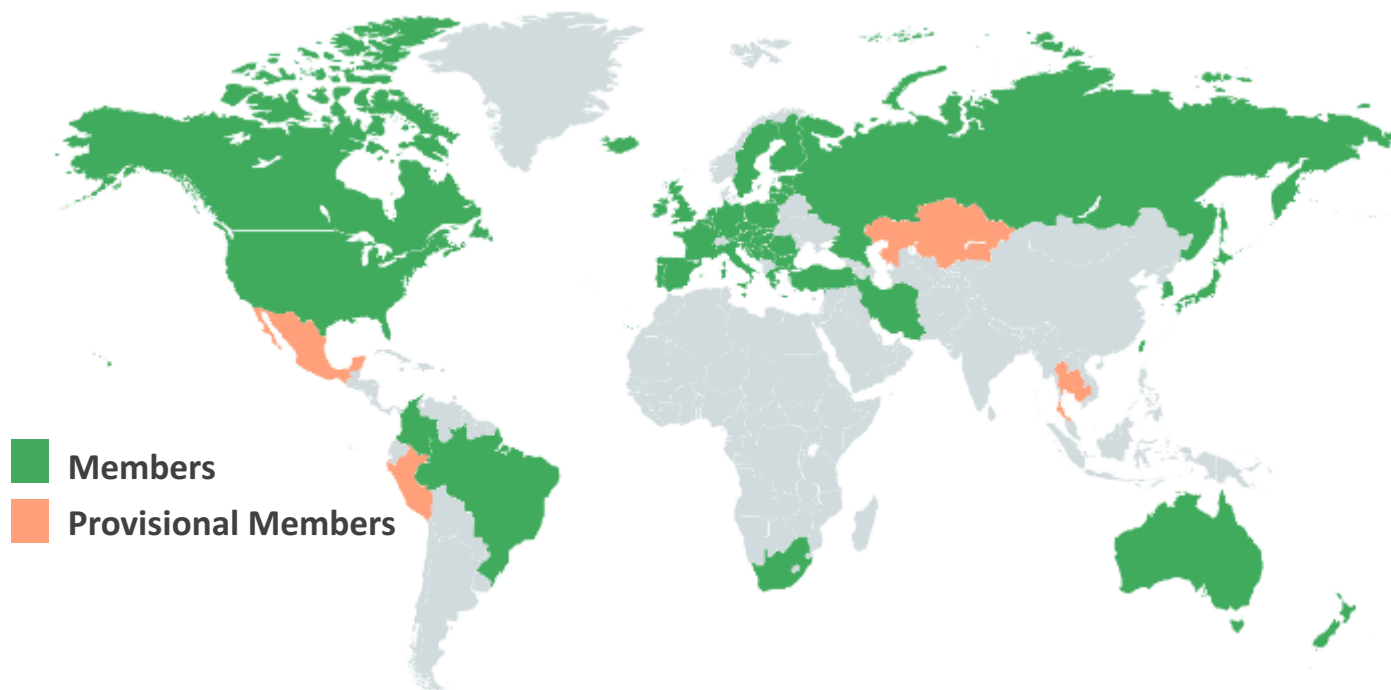


International Partnership

- SIA has joined INHOPE, International Association of Internet Hotlines, since 2016 and is actively pursuing the removal of CSAM in collaboration with INHOPE member countries.

- Have conversation with representative such as UN Special Rapporteur, Head of End Violence against Children and present “End Violence Solutions Summit” held in Stockholm next week.

- Keep good relationship with multi-stakeholders through events, meetings, and discussion.


