# Mission

## 維護/保護兒童及青少年網上安全的線上舉報協作機制

- 互聯網成為兒童日常生活必不可少的一部分，為他們提供獲取資訊、社交網絡的新渠道，卻也使他們處於網絡上的新危險中。
- 香港一直以來缺乏一套舉報機制讓大眾舉報網上兒童性虐待材料（ Child Sexual Abuse Material, CSAM ）。
- 與此同時，面對網上罪行（ CyberCrime ）和網上欺凌（ Cyber Bullying ）等問題更需不同持份者共同為兒童及青少年提供支援。

## 於2017年2月7日 第一次圓桌會議



- 多個關注兒童網絡安全的持份者就兒童及青少年網絡安全問題召開了第一次圓桌會議討論相關議題
- 席間亦邀請到亞太地區相關的機構分享海外經驗。
- 經過研究及討論後，與會者倡議共同籌組「網上支援協會」（eHelp Association）作為多持份者合作平台
- 共同為促進兒童及青少年線上安全和保護出一份力量。

- 海外專家培訓和與本地社區的經驗分享





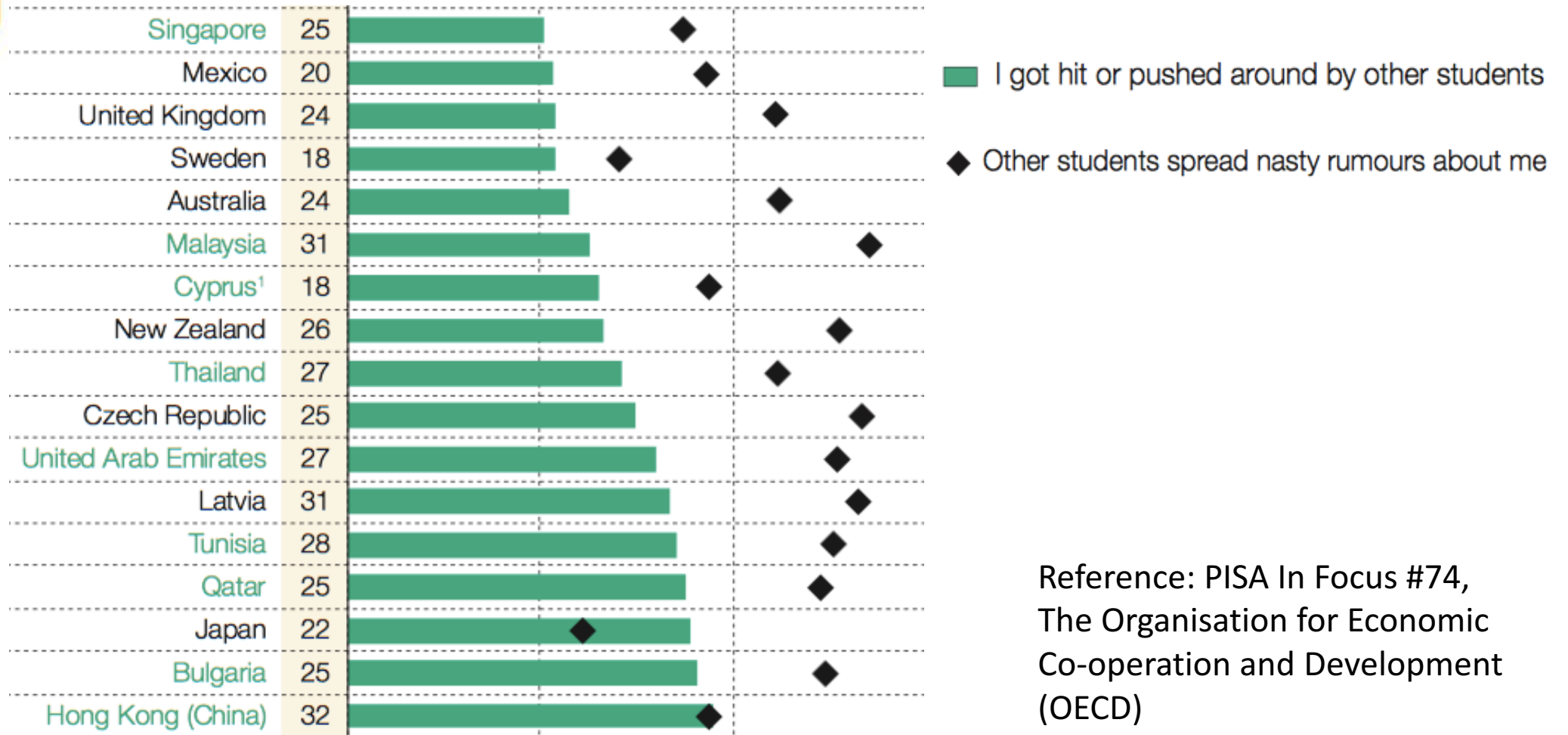

# Situation in Hong Kong: CSAM

HK laws against and for the prevention of child pornography

- Child pornography is still accessible in traditional formats, such as printed materials and videotapes, however the Internet plays a major role in promoting child pornography
  - Control of Obscene and Indecent Articles Ordinance (Cap 390)  
[淫褻及不雅物品管制條例]
  - The Prevention of Child Pornography Ordinance (Cap 579)  
[防止兒童色情物品條例]
  
- However, many view this Ordinance as inadequate



# Service Content

- **Core Service Content: Online Reporting Mechanism**

The mechanism at the same time is with the collaboration with different stakeholders including police force, Internet service providers, technical community and civil society for creating a safer Internet for children and youth.

- (i) Operate the Online Reporting Mechanism
- (ii) Refer the illegal information to the Global Reporting Mechanism or law enforcement in Hong Kong as follow-up action
- (iii) Refer the related cases to social workers to follow-up.

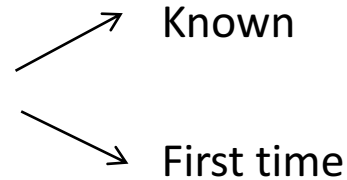
